Public Safety Committee Meeting May 4, 2017, 7:00 pm

- 1) Silence all cell phones
- 2) Call to Order and roll call of Officers: The meeting was called to order at 7:00 pm by Committee Chair Gail Kowalkowski. Trustees present were: Kowalkowski, Pete Anzia, and Rose Sauers. A quorum was established. Also in attendance was Village Marshal Leon Anzia and DPW Superintendent, Danny Birenbaum
- Open Meeting Law Compliance Check: This meeting is in compliance with the Open Meetings Law of the State of Wisconsin.
- 4) Pledge of Allegiance to the American Flag, Moment of Silence: All in attendance stood for the Pledge of Allegiance and a moment of silence.
- 5) Approval of Minutes:
 - i) **Public Safety Committee Meeting, March 2, 2017** Motion was made by Sauers and seconded by P. Anzia to approve March 2, 2017 committee meeting minutes. Ayes Kowalkowski, P. Anzia, and Sauers; Noes none. Abstain none. Motion carried.
- 6) Agenda Items:
 - a) **Monthly update report for Village Board Meeting:** L. Anzia reported that he had 22 patrol hours and addressed 3 complaints for the month.
 - b) Review Village Marshal's patrol plan for Village of Belgium rummage sale and the Memorial Day parade:
 L. Anzia shared that he will be stopping traffic for the parade. He will be doing a patrol on Saturday morning for the rummage sale. Kowalkowski asked if there are any issues with residents leaving items curbside after the rummage sale. Birenbaum and L. Anzia reported that this has not been an issue in the past.
 - c) Review of cell phone usage bills for the village marshal: The committee reviewed the report provided. The cell phone charges have been consistent month to month. L. Anzia added that the cell phone is only used if someone calls him. The committee would like to determine the actual minute usage for the Marshal's cell phone and if switching to a track phone would be more economical. Kowalkowski pointed out the large cell phone bill in 2015. There was discussion regarding why this was so high.
 - d) Request Village Marshal provide an update on the tracking of Village complaints and tickets in computer:

 L. Anzia reported that he has been recording all complaints into the spreadsheet.
 - e) Address speed limit sign postings: The committee received an email from a resident with concerns of the traffic speed on KW by Heritage Park and within the Village limits. Birenbaum will contact Jon Edgren from Ozaukee County to verify if the speed limit posting needs to be updated. Kowalkowski made a motion to refer the speed limit sign posting to Public Works committee. Motion was seconded by Sauers. Ayes P. Anzia, Kowalkowski, Sauers; Noes none; Abstain none. Motion carried.
 - f) Address dog at large complaints: The committee received an email from a resident with concerns of dogs running at large in Heritage Park. Birenbaum confirmed that Heritage Park is not currently posted "no dogs allowed". It is a Village ordinance that no dogs are allowed in Village parks. Kowalkowski made a motion to refer the issue to Parks, Recreation, & Forestry committee to review the posting of "No Dogs Allowed" in Village parks. Motion was seconded by Sauers. Ayes P. Anzia, Kowalkowski, Sauers; Noes none; Abstain none. Motion carried. Kowalkowski made a request of L. Anzia to keep a watch out for dogs at large.
 - g) Discuss and make recommendation of legal review document from League of Wisconsin Municipalities: Kowalkowski explained that Wisconsin courts recently ruled that a village ordinance regulating the residency of child sex offenders with in the Village's borders was unconstitutional. The League of Wisconsin Municipalities has published a review of this court case and how it may affect municipalities. Kowalkowski made a motion to recommend to the Village Board to have Village Attorney review this document to ensure that the Village's ordinance are in compliance with this new ruling. Motion was seconded by P. Anzia. Ayes P. Anzia, Kowalkowski, Sauers; Noes none; Abstain none. Motion carried.
